# **Statement of Purpose**

Staffing: The SMT are supported by a multi-disciplinary clinical team consisting of sessional GP's, Nurse Practitioners, A first Contact MSK Practitioner, Healthcare Assistants, Care - Coordinators and a Pharmacy Technician.

A team of receptionists/administrators also assist the Practice Manager. Financial Governance and Management is overseen by Mr Steven D'Cruz assisted by Mrs Joy Underwood. The surgery operates from a split site located in the South Reading area, close to the local Hospital Foundation Trust and just outside the main town centre of Reading. We have remote access to a hosted server and use INPS (Aeros Vision) as our clinical management system.

Under the Health and Social Care Act 2008 (The Care Quality Commission (Registration) Regulations 2009 Part 4), the registering body (CHC Ltd) is required to provide to the Care Quality Commission a statement of purpose.

- Maternity and midwifery Services
- Treatment of Disease, disorder, or injury

# D) Details of the services provided by Pembroke Surgery

Routine medical checks and general medical services
NHS relevant prescriptions and medications or a private prescription can be issued.

## **Immunisations**

- **Immunisation Programmes** as and when agreed by the Department of Health.
- A Childhood immunisation programme is provided by our Practice Nursing Team
- Foreign travel advice and NHS immunisation is provided by our Practice Nurses
- **Seasonal vaccination** At Pembroke Surgery we offer 'at risk' groups the flu/covid and pneumococcal vaccine in seasonal clinics and during routine appointment sessions.

**Child Health Surveillance Checks-** Are provided by our clinical team working to locally agreed guidelines, with our Health Visitor Team.

**Respiratory services** – Pembroke Surgery has facilities across both sites for Spirometry (lung function testing.) and chronic disease management.

**Diabetic clinic** – Pembroke Surgery offers specialist diabetes services to provide ongoing care for our diabetic patients with a diabetic lead nurse covering the long-term management and monitoring of Diabetes.

Family planning services are offered by our clinical team which also include the fitting and removal of contraceptive implant systems.

**Phlebotomy** Pembroke Surgery offers various clinics across the week for **blood screening** with all our nursing team at both our sites.

**Midwifery** The community midwife operates from the nearest location for the patient as chosen by the midwifery hub. The midwife works with the clinicians to provide supervised antenatal care following local guidelines set out by the Royal Berkshire Foundation Trust following the latest NICE principles. The midwifery team will undertake deliveries in hospital and at home where appropriate.

**Minor surgery -** We offer a number of minor operations patients are advised as appropriate. The minor operations are held with Dr Gerard D'Cruz.

Ear syringing and audiology Pembroke Surgery has facilities for audiology and ear syringing.

**Well person checks** these can be carried out with any of our nurse team.

**ECG monitoring** At Pembroke Surgery we can offer this service with any of our nursing team at both our sites.

**Cervical screening** - At Pembroke Surgery, our nurse practitioners are qualified to carry out cervical screening.

**Ultrasound Screening** – Dr Gerard D'Cruz is able to provide a variety of external ultrasound screening checks for our patients.

## First Contact MSK Practitioner-Mr Ranjish Kumaraswamy

is a registered health practitioner with an expertise in Musculo-skeletal conditions. As a "First Contact Practitioner" he is able to evaluate, examine and agree management plans for patients presenting with a Musculo-skeletal issue. He is also able to refer patients for prolonged courses of physiotherapy, as well as refer into secondary care for further imaging and orthopaedic/pain management review.
